

# Adoption Agreement for PCA Rescue

Papillon Club of America, Inc. Rescue, and the undersigned person (the "Adopter/you") in consideration of the mutual promises in this Agreement and other good and valuable consideration, intending to be legally bound by this Agreement, agree to the following terms and conditions:

1. **The Dog.** We are placing the following sterilized papillon dog/puppy (the "Dog") with you, the adopter:

2. **Adoption Fee.** We require an adoption fee for the Dog, to help defray our expenses for the Dog's expenses and veterinary care. For your convenience PCA can accept money orders, cashier or bank checks, and Paypal. We have a very limited budget. If the Dog is not a good fit for your family and is returned within three weeks from the date of adoption, the adoption fee less \$50 will be refunded. By signing this agreement you are agreeing to this \_\_\_\_\_ fee for consideration of adoption of aboe mentioned dog..

3. **No Representations.** You understand that this Dog was previously unwanted or lost and may have been rescued by us from a dangerous, unhealthy and/or cruel situation. This could have long-lasting effects on the Dog. You agree that we are making no representations or warranties about the health, condition, personality or temperament of the Dog.

4. **Care of the Dog.** You agree to provide the Dog with a life-long caring home, fresh water, wholesome dog food, and adequate outdoor exercise. You will treat the Dog as a household pet, companion and family member. You agree to abide by the dog laws in force for your municipality/state. You agree never to use the Dog for dog fighting or any other "sport" in which one animal is pitted against another with physical contact and you agree never to beat or taunt the Dog in order to promote aggressive characteristics.

5. **Veterinary Care.** You agree to have the Dog examined by a licensed veterinarian within ten (10) days of placement and not less than yearly thereafter. You will consult with a veterinarian for appropriate vaccination schedules, heartworm preventative and other required treatment. In case of illness or injury, you agree to seek prompt veterinary care.

6. **Transfer/Euthanasia.** In the event that you are unable to keep this Dog, you agree to notify PCA Rescue, either by mail or by phone. You agree not to abandon, give away, sell or dispose of the Dog in any way without this notification so that PCA Rescue will have an opportunity to rehome the Dog. You agree that you may not euthanize the Dog except in the case of the Dog's terminal illness or injury, or old age accompanied by pain and suffering. Euthanasia must be performed by a licensed veterinarian and you will notify PCA Rescue of the euthanasia.

7. **Lost Dog.** You agree to make a serious effort to find the Dog if it becomes lost, by immediately (a) filing lost reports with the local police, animal control authorities, animal shelters, local veterinarians, and PCA Rescue ([www.papillonclub.org](http://www.papillonclub.org)) (b) posting lost dog signs and (c) putting an ad in the paper.

8. **Breach of Agreement/Liquidated Damages.** PCA Rescue reserves the right to follow through on this adoption in order to protect the welfare of the Dog. In the event that you do not comply with the terms of this Agreement, or the Dog is abused or neglected while in your care, one of our remedies will be to recover the Dog from you upon demand. To this end, you will agree to allow visits (possibly unannounced) to your home to assess the status of the Dog and the conditions under which it is being kept. After the demand, you will immediately surrender the Dog to us. In addition, without waiving any of our rights under this Agreement, you will owe us a payment in the amount of \$250, agreed between us as just and reasonable liquidated damages to compensate us for our costs and expenses in connection with your breach of this agreement.

9. **No Liability.** PCA Rescue is not liable for any claims, legal actions, losses, injuries, damages, costs, expenses or liabilities whatsoever in connection with your adoption or ownership of the Dog.

10. **Entire Agreement/Modification/Binding Effect.** This Agreement is the entire agreement between you and us, and supersedes any prior understandings between you and us with respect to the subject matter of this Agreement. No modification of this Agreement will be valid unless in writing duly signed by both you and us. This Agreement is binding upon your and our heirs, assigns, successors, personal representatives and executors. This agreement between the parties is contained herein.
